

COP29 in Baku, Azerbaijan November 11-22	<b>Finance</b> will be a key focus of COP29 as trillions of dollars are required for countries to drastically reduce greenhouse gas emissions and protect lives and livelihoods from the worsening impacts of climate change.

# **Major climate reports**



#### 24 October 2024 UN Emissions Gap Report

As climate impacts intensify globally, the UN's latest report finds that nations must deliver dramatically stronger ambition and action in the next round of Nationally Determined Contributions (NDCs) or the Paris Agreement's 1.5 C goal will be gone within a few years.

A failure to increase ambition in these new NDCs and start delivering immediately would put the world on course for a temperature increase of 2.6 – 3.1 C over the course of this century. This would bring debilitating impacts to people, planet and economies.

# International Energy Agency (IEA) Annual Report: World Energy Outlook 2024

This year's report underscores how geopolitical tensions and fragmentation are creating major risks for both energy security and for global action on reducing greenhouse gas emissions. Key highlights from the 2024 report include:

- The world is set to enter a new energy market context in the coming years marked by continued geopolitical hazards but also by relatively abundant supply of multiple fuels and technologies.
- The contours of a new, more electrified energy system are coming into focus as global electricity demand soars.
- For clean energy to continue to grow at pace, greater investment in new energy systems, especially in electricity grids and energy storage, is necessary.
- Despite growing momentum behind clean energy transitions, the world is still a long way from a trajectory aligned with its net zero goals.
- In some regions of the world, high financing cost and project risks are limiting the spread of cost-competitive clean energy technologies to where they are needed the most.

# Canadian Climate Institute's takeaways for Canada from the 2024 World Energy Outlook's (WEO)



#### Key takeaways:

- The age of clean electricity is here: Canada's electricity generation will need to grow 1.6 to 2.6 times bigger by 2050 to meet future electricity demand.
- More electricity = less fossil fuels: Demand for each fossil fuel will peak before 2030. As global demand declines, this will have implications for Canada's oil and gas sector's long-term competitiveness.
- The clean energy transition can help reduce household bills and reduce the exposure to volatile fuel costs.
- Canada's critical minerals will be in major demand.
- Canada can build on policies still in development, strengthen some measures and add a few targeted measures.

# Climate Action Network Canada

Paving the way for an equitable future: Recommendations for Canada's next Nationally Determined Contributions (NDCs).

The Paris Agreement lays out a clear path for signatory countries to increase the ambition, scope and breadth of their climate policies and targets, known as Nationally Determined Contributions (NDCs). Every five years, countries are required to submit updated NDCs, each round representing a progression beyond the previous; the next round is due in early 2025.


